All kindergarten and first-grade students at Union East Elementary had the opportunity to code using "Beebots" this year with the help of WNYRIC technology integrator Deedee Stasiak! Beebots are small, programmable robots designed for kids. Programming a Beebot provides students with practice counting, sequencing, problem solving, estimating, directionality, teamwork and collaboration. These lessons started out as an introduction to coding and ended with students being able to write their first lines of code!
