Under the instruction of Scott Grandits, Morgan has learned about criminal minds, courts and corrections, forensics and more.

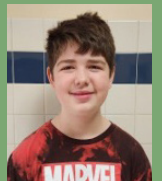
"Morgan has maintained a 100 average throughout her time in the program," Grandits said. "She is very helpful to classmates and the Potter building as a whole."
